Thanks to our will, through a joint effort, in 2005, we, the Petru Maior University of Târgu-Mures, Romania (today, UMFST "George Emil Palade"), namely Szabo Zsuzsanna, Dragos Chilea, Daniela Valea, Ximena Moldovan, Ramona Coman, Daniel Stefan, Magyari Annamaria, set off without hesitation and compromise with our colleagues from Miskolc University (Hungary), with the distinguished professor and rector later Torma Andras, Erdos Eva, Balazs Szabo, joined by the team of colleagues from the University of Versailles-Saint Quentin en Yvelines (France) in the person of Stefan Manson, Jean Luc Pennot, Yves Poirmeur, Beatrice Boissard, Emma Bursier and the team of colleagues from the University of Salento, Lecce (Italy) Luigi Melica , Luigi Di Vigiano, Vincenzo Carbone.

This approach was joined by professors, researchers, scientists from Northern Ireland, Greece, USA, Bahrain, Lebanon, Germany, Tunisia, Latvia, Brazil, Spain, Moldova, Israel, Great Britain, Turkey and many others, and prestigious universities and academic institutions from around the world have contributed, such as Corvinus University of Budapest, Technical University of Kosice (Slovakia), Romanian Academy, SNSPA Bucharest, University of Strasbourg, International Criminal Bar.

What have we achieved together? 15 International Conferences, countless other conferences, symposions, colloquia, an International Association *Pro Iure*, we have all contributed to the publication and writing of the legal journal "Juridical Current", and have established and organized the first European Professional Master in Public Administration, we have edited countless courses and specialty books for student use and more.

I made this long and descriptive introduction precisely in order to understand the true and complex participation and contribution of the professor and the rector Torma Andras. He has been involved in our activity since 2005 in organizing countless international scientific events, is a member of the Scientific Committee of the Journal "*Juridical Current*", is an active member of the "*International Association Pro Iure*", has participated in the organization and establishment of the European Professional Master in Public Administration, he wrote and collaborated in many university courses in this endeavor. Just as a recognition of his rich activity and in connection with the scientific life of the "*Petru Maior*" University of Tg-Mureş (today UMFST "George Emil Palade") he was awarded the title of *Doctor Honoris Causa* of this university. Recognizing his contribution to the spiritual, educational and humanistic edification of generations of students in the field of law, as well as merits in scientific research, the International Scientific Committee of the *Juris Praecepta* Foundation awarded professor Torma Andras the Diploma of Excellence and *Tudor Drăganu* Medal for the entire activity carried out.

He participated in the Conferences in Tg-Mures, Versailles, Gallipoli, Miskolc, Lecce, Strasbourg, Athens, Constanța, Paris, etc. I can't help but notice the friendship, the warmth, the professionalism, with which the rector greeted the delegations of our university many times. Because all these had to bear a name, it could not be other than Torma Andras, a name in law earned through work and dedication.

Probably the long history will not remember in its memory what we and our generation have done, but the history of the present can hold an adage acknowledging that Mr. Torma Andras along with his friends and colleagues was a worthy ambassador in defense of this city of built on the immortal principles of law, formulated in Digeste, by Ulpian *Juris Praecepta sunt haec : honeste vivere, alterum non laedere, sum quique vivere*.
